#### **STEP ONE: CREATE YOUR SUN PROTECTION POLICY**

Our on-line policy maker makes it easy for schools to tailor and download their own Sun Protection policy. #### **STEP TWO: COLLABORATE WITH PARENTS**

#### STEP THREE: CONDUCT A WHOLE SCHOOL ASSEMBLY

A range of bespoke resources including assembly plan, presentation slides, script, music and song are available to help schools conduct their assembly, engage children of all ages and reinforce the importance of a whole school approach to sun safety.

#### **STEP FOUR: CONDUCT INDIVIDUAL CLASS LESSONS**

A comprehensive range of fun and engaging, curriculum linked, educational resources and activities for key stage one and two pupils are provided to introduce, reinforce and increase knowledge regarding 'safe and unsafe exposure to the sun and how to prevent skin cancer'- which forms part of the new PHSE Curriculum.
